Presentation from PCI

PCI Regional Coordinator, Barbara Webster, gave a presentation on PCI and displayed relevant maps for the region. She demonstrated the website and showed the search tool. The mission of PCI is to help people find providers, market what is available, help providers and communities with access and adoption needs. **Access, adoption, data.**

Community Leaders: Look at industrial parks, know what a person needs to do to get the good access.

Barb mentioned that adoption will likely only be hindered by cost and access in a few years due to the younger generations use and need for technology. For today, we still need to assist with adoption through making it easy to find access, promoting training and marketing relevant use.

Dave Mollet gave a presentation on what the Illinois Century Network is doing in the region, including their pricing model. There were a few expressed concerns with public build competing with private builds. Committee needs to work to make the private build as beneficial for providers as possible. The pricing location on ICN web site was shown.

If there are any questions in regards to the ICN build and how providers can utilize, Dave will be available to answer.

Kim Harber led a discussion on the Illinois Network Alliance. Providers can also get info on that build from PCI.

Nathan Stooke mentioned that Wisper ISP will be turning on 36 new towers in the next 90 days. Barb wanted to be sure to get that info so committee could get word out to those impacted communities.

Ed Van Hoose led a discussion on the electric cooperatives. Tag AIEC to connect to coops. All telephone coops have fiber or are in the process (i.e., Wabash 477 miles) Prairie Power will likely build an entire fiber network. Coops do the last mile. Also, a Mt. Vernon Provider mentioned needing a piece of equipment, and Ed said he might be able to help him out.

Three communities in the region fit Community Connect Grant Requirements. (We later found that the communities also have to be on Rand McNally or on Census to be eligible so Rosedale was only one in region truly eligible. One provider is researching possibility.)

Gigabit Grant Challenge

Frontier is working on grants in the Olney/Carbondale communities. Grant is highly competitive and you have to ask for at least \$1 million. Barbara Webster thinks there will likely be grants around the State. If you have any specific questions and/or general questions let Barbara know. Likewise, innovation and jobs are the driving force of the competition. It was asked if there was a scoring sheet and the answer was not at this time.

Chadd Thompson of Tincans Wireless: If you go off the pricing model, it is not practical. No way to give a gig worth of capacity to a community. Idea behind the whole concept is to just spark innovation as much as infrastructure. We can all shoot holes in a lot of this but the opportunity is out there to get communities to be innovative.

Prevailing wage requirement was discussed It's a problem for rural Illinois. Can double the cost. Some plan on building the entire network in-house. Cost of living is not the same here.

Capital Development Bond: State & Federal wages, CapX has a lot that figures into the labor side of that.

Evaluation is done by heads of various state departments and others. Ensure you have a sustainable model.

- Stop talking about access we don't have and start talking about what access we do have
- Internet and Broadband Training to improve demand
- Demand aggregation may be the greatest problem:

Lesson - non-interested party must be at center. Connect SI started to be seen as a competitor by some.

Tell success stories.

Economic Model: weaknesses, strengths, etc. What do we have to do to make technology even more impactful?

May need Communities of Interest Committees: Technology agnostic. Econ Dev, Healthcare, Education, etc. Group chooses what is needed.

Connect SI Model: Mr. Kim Harber talked about the Connect SI program and how we can learn from it. Shortage of nurses in Southern Illinois: online nursing program. No need to reinvent the wheel.

The teams (called "eTeams") for other active PCI Regions were mentioned. Volunteers from a variety of organizations assist in the effort in the Southern and Southeast Central Region. Those include providers, U of I Extension, Colleges, high schools, libraries, Farm Bureaus, regional plan commissions, local economic development, hospitals, ICN, and many others.

The group was given a break after one hour in order to network and was asked to introduce themselves and the company they worked for prior to breaking. Time was also allocated from 3 to 3:30 for networking and questions.

Thank you coffee cards were given to Edie Koch with DCEO and Jim Pennekamp with SIUE for all the assistance in setting up the meeting. Art Borum from SCIGA was unable to attend, but also helped with meeting planning. (Also a special thank you to the Lewis and Clark Community College for allowing the group to use their wonderful conference room.)

The group discussed next steps. Another meeting will be held in late July or early August to determine how best to address assets and needs of region that are tied to broadband.
